### How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility". In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

ATB Investment Management Inc. has rated the volatility of this fund as **Medium**.

Because this is a new fund, the risk rating is only an estimate by ATB Investment Management Inc. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### No guarantees

Like most mutual funds, this fund doesn't have any guarantees. You may not get back the money you invest.

### How has the fund performed?

This section tells you how Series O units of the fund have performed over the past year. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how Series O units of the fund have performed in the past year. This series of the fund did not drop in value.



#### Best and worst 3-month returns

This table shows the best and worst returns for Series O of the fund in a 3-month period over the past 1 year. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

The annual compounded rate of return of this series of the fund was 15.10% since inception. If you had invested \$1,000 in this series of the fund when it was created, as at June 30, 2018 your investment would be worth \$1,263.

## Who is this fund for?

### Investors:

- who have a long-term investment horizon
- looking for long-term capital appreciation
- willing to accept volatility in the value of their investments and medium investment risk
- wishing to diversify their asset class exposure by manager and management style

This fund is not suitable for those who have a short term investment horizon or are looking for a steady source of income.

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund outside a registered plan, fund distributions are included in your income for tax purposes, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series O units of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charge** – There are no sales charges applicable to Series O units.

**2. Fund expenses** – You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of June 30, 2018 the fund's expenses were 0.06% of its value. This equals \$0.60 for every \$1,000 invested.

### More about the trailing commission

No trailing commission is paid by ATB Investment Management Inc. to your representative's firm in respect of Series O units.

**3. Other fees** – You may have to pay other fees when you buy, hold, sell or switch units of the fund.

<b>Fee</b>	<b>What You Pay</b>
<b>Representative Fee</b>	In order to be eligible to purchase Series O units, you must participate in a fee for service arrangement with your representative.
<b>Short-term trading fee</b>	Up to 2% of the value of units you sell or switch within 90 days. This fee goes to the fund.
<b>Management Fee</b>	You negotiate and pay the management fee with respect to Series O units directly with and to ATB Investment Management Inc. The management fee will not exceed an annual rate of 1.75%.
<b>Bank Wire Costs</b>	If you request redemption proceeds be forwarded to you by wire, ATB Investment Management Inc. may charge you the \$10 cost incurred with this delivery method.
<b>Dishonoured Items</b>	ATB Investment Management Inc. may charge you a fee of \$25 should any items, such as a cheque or purchase order, be returned because of insufficient funds in your account.
<b>Account Closure in 1st Year</b>	If you close an account with ATB Investment Management Inc. or its affiliates within a year of opening such an account, you will be charged a fee of \$50 with respect to such closure.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
